

“40 Shades of Green” Pub Tour – 2021/2022

TERMS & CONDITIONS:

- Passengers who arrive into Ireland on or after July 19th 2021 must prove they are fully vaccinated for COVID-19 - Travellers from the USA must show their CDC Vaccination card and EU citizens must avail of a Digital Covid Certificate.
- Our highest priority is the health and safety of all of our passengers, group leaders, staff, suppliers, and local communities. We have a duty of care to ensure our passengers safety. By making the decision that all passengers must be fully vaccinated prior to travel with us, we are reducing the risk of harm to all travellers. In addition, as an ethical tour operator, we have a responsibility to ensure that we are not adding additional and avoidable strain to any country's healthcare system.
- 40 Shades of Green Pub tour is a Land only tour package – Flights are not included. We strongly recommend that you book a flight that allows for change of dates or full refund in case you cannot travel for any reason.
- Your booking is made and operated by Specialized Travel Services with their HQ in Ireland.
- Company registered number 48828.
- The package price is in USD\$ and is based per person sharing Twin/Double occupancy room.
- Single supplement applies for single rooms.
- A deposit of 10% is required to confirm booking and reservations cannot be guaranteed until your deposit has been received.
- The deposit is refundable if the tour does not operate for unforeseen reasons, e.g. travel restrictions in Ireland or your country due to COVID 19.
- If you are sharing this tour with friends – we can hold your place /places for 7 dates free of charge, just fill in the enquiry form.
- Once booked our team will be in touch to confirm more specific details/special requests. E.g. dietary requirements.
- Final details of tour will be sent to you 8 weeks prior to start date of the tour.
- Final payment is payable 6 weeks prior to start date of the tour (you can pay in instalments if it makes it easier to spread your payments).
- The tour will operate with a minimum of 20 participants.
- If you have any query on this tour prior to paying your deposit – please fill in your query on the booking form and we will answer any outstanding question prior to paying your deposit.
- Our aim is to be as flexible as possible while international travel resumes. We will observe all local government guidelines in the operation of our tours and will advise of these 8 weeks prior to start date of tour.
- Specialized Travel Services strongly recommends Travel Insurance to cover trip cancellation & interruption, medical & health insurance, loss of baggage or trip delay. You can book travel insurance through our partners A+ Program Protection.
- **BOOKING ON BEHALF OF OTHERS:** If you make a booking for anyone other than yourself, you are considered the designated contact person for those other travellers. You represent and warrant that you are legally authorized to act on their behalf; that you have obtained all required consents; and that you will inform them of these terms and warrant that they accept and agree to them. You are also responsible for making all payments due for your booking; notifying us if any changes or cancellations are required; and keeping the other travellers informed of all information relevant to your trip.

- **COVID-19 COVER up to 6 weeks before your tour** - Should COVID-19 be an issue in 2021/2022 then there's extra flexibility in any of these situations: Should your airline cancel or change your flight dates due to COVID-19, or your Government or the Irish Government recommend against traveling due to COVID-19. If either of these situations should occur, you can transfer the full amount paid to a future tour with it or get a refund of all monies paid (less the 4% card charges).

- All documents are issued, and all land only arrangements covering hotel accommodation, transport, tours, transfers and all other land services required by the traveller in Ireland, are made on the explicit understanding that Specialized Travel Services act only as agent and as such admit no liabilities whatsoever for any loss, damage, delay or injury to persons or property arising out of, or in any connection with any act of neglect or default however caused, either directly or indirectly by the principals or persons or their agents or servants, who shall provide such hotel accommodation, transport, tours, transfers or all other services provided.
